PRE-LICENSING BAIL EDUCATION

Bail license applicants taking the twelve-hour Pre-Licensing Bail Education course will attend class for two consecutive days. Registration begins at 8:30 am, the class begins at 9:00 am and concludes at 4:45 pm.

Lunch will be served from 12:00 - 1:00 pm

(Included with registration fees)

If you are a bail license applicant you must include your **Social Security Number** on your registration form. Please use your name as it appears on your bail license application.

CBAA's Pre-Licensing Bail Education course is designed to give students a broad overview of the laws and regulations governing bail in California and to assist students in their preparation for the State's bail license examination.

The instructor, Thomas Kiefer, was a criminal court clerk for three years. Then, in 1984 Mr. Kiefer took a position with a bail general agency. In 1995 he began work in management for surety insurance companies in their bail and court divisions. He was a licensed bail agent for many years and has taught CBAA's bail classes since their inception in 1994. Currently he works for surety insurance companies as a bail consultant and expert witness. He has over 20 years experience relevant to bail.

CBAA's courses are approved by the California Department of Insurance.

Class Change Policy
